

## Official Rules: September 2025 – Instagram Giveaway

**Promotion Description.** This promotion is sponsored by RBD Hawaii Restaurants Limited dba Pizza Hut Guam (“Sponsor”). The promotion begins Thursday, September 18, 2025 at 10:00 am and ends on Monday, September 22, 2025 at 11:59 pm HST. Promotion is void where prohibited. By entering, each entrant accepts and agrees to be bound by these promotion rules.

**Eligibility.** No purchase necessary to enter or win. Qualifying entrants must be Guam or Saipan residents, 18 years or older at the time of contest period. Employees and immediate family members of employees of RBD Hawaii Restaurants Limited, and participating companies and their respective parent companies, affiliates, subsidiaries, agents, and their advertising and production agencies are not eligible to participate in this promotion.

**How to Enter.** Follow @pizzahutguamsaipan on Instagram, Like, Save, Repost and Share the post to stories the post dated September 18, 2025, and tag two (2) friends. Participants will have until Monday, September 22, 2025 at 11:59 pm HST to submit their entry.

Entry materials that have been tampered with or altered are void. Any questions regarding the number of entries submitted by an individual or the authorized account holder of an email address shall be determined by Sponsors in their sole discretion, and Sponsors reserve the right to disqualify any entries by persons determined to be tampering with or abusing any aspect of the promotion.

**Prize(s).** One (1) Instagram winner will receive a \$50 Pizza Hut eGift Card.

**How the Prize is Awarded.** One (1) Instagram winner will be selected at random, and will be notified on Tuesday, September 23, 2025, via IG Story. Once the winner has all qualifications verified, a \$50 Pizza Hut eGift Card will be emailed to the email address provided. Redeemable in-store only. Must mention coupon at time of purchase. Not combinable with other offers or specials.

Winner must provide a valid Guam or Saipan address and email by 5:00pm HST on Tuesday, September 30, 2025 to receive the prize. If no response is received before this deadline, the prize will be forfeited and another winner will be chosen, with the prize required to be claimed on or before October 7, 2025, and so on.

**Odds of Winning.** The odds of winning depend on the number of entries received, and one (1) winner will be selected at random amongst all entries on Instagram.

**Conditions of Acceptance of Prize.** Winner will be requested to provide proof of the following: 1) Proof of age, 2) Proof of Guam or Saipan residence. Examples of these include but are not limited to: Guam/Saipan state ID, driver's license, utility bill, etc.

It is the winner's responsibility to assure the address provided to Sponsor is accurate and all requirements are met prior to receiving the prize.
